Nursing Home Physicians: Roles and Responsibilities

Verify the accuracy of verbal orders at the time they are given and authenticate, sign and date them in a timely fashion, no later than the next visit to the patient. Provide documentation required to explain medical decisions, that promotes effective care, and allows a nursing facility to comply with relevant legal and regulatory requirements;

Role of the Attending Physician in the Nursing Home | AMDA

The documentation of the patient's condition and the services provided determine the level of E/M submitted to Medicare. Patients within a skilled nursing facility (SNF) or nursing facility (NF) require evaluation and monitoring at least every 30 days for the first 90 days in the facility and at least every 60 days thereafter.

Federally Mandated Visits and Timing of Services

Based on the above documentation, the service may be reported using level I Initial Nursing Facility Care code 99304 Initial nursing facility care, per day, for the evaluation and management of a patient, which requires these 3 key components: a detailed or comprehensive history; a detailed or comprehensive examination; and medical decision making that is straightforward or of low complexity.

In a best-case scenario, documentation of time for an E/M visit should include the following to determine if the counseling and care coordination accounted for more than half the time: The beginning and ending time of the counseling and/or coordination of care
